December 2024 Find the Money Maker Social Media Promotion

OFFICIAL RULES:

1. ENTRY PERIOD: The North Carolina Education Lottery ("Sponsor") December 2024 Find the Money Maker Social Media Promotion ("Promotion") begins on Tuesday, December 3rd, 2024 at 12:00 a.m. Eastern Time ("ET") and will end on Monday, January 6th, 2024 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish four (4) "Promotion Posts" to its official Facebook page (https://facebook.com/nclottery). The Promotion will include four (4) Entry Periods and one (1) drawing at the conclusion of each Entry Period, for a total of four (4) drawings in the Promotion. Each drawing will be for five (5) winners, for a total of twenty (20) winners in the Promotion, who will each receive ten (10) \$8 Million Money Maker scratch-off tickets (Game #972) ("Prize"). Estimated Retail Value ("ERV") of each Prize is \$500. ERV of all Prizes in this Promotion is \$10,000.

2. ELIGIBILITY: Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible

to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number, and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures, and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. 3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. All entries must be submitted within the Promotion Entry Period for each applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will visit the Promotion microsite at https://FindtheMoneyMaker.com and complete the activity. Users will screenshot the hidden \$8 Million Money Maker scratch-off and share that screenshot on the official Facebook Promotion Post during each Promotion Entry Period. A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during each Entry Period on the corresponding official Facebook Promotion Post for that Entry Period. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Odds of winning in each drawing depend on the number of entries received for each drawing. Entries will be collected via qualified comments on each official Facebook Promotion Post at the end of the Entry Deadline period for each drawing. Five (5) winners will be randomly selected in the list of entrants in each drawing to receive a Prize, for a total of twenty (20) winners in the Promotion. ERV of each Prize in this Promotion is \$500. Total ERV of all Prizes in this Promotion is \$10,000.
